## **Tee Times**

- Give the passes to whomever you like; customers, staff, and/or management.
- Primary and Secondary contacts receive advance booking, however anyone can book and use the pass under our regular booking policies.
- Each pass is valid for four (4) green fees and two (2) power carts, and will be used as such. If unforeseen circumstances leave you with 2 or 3 players, we will give out a single pass to be used on another day.
- All cancellations must be made within our standard booking policy at each course. (24 hours' notice)
- A maximum of two starting times may be booked in any one day. If more than two times are required please contact our Tournament Director.
- Tee Times **do not** expire at the end of the membership year and may be transferred to the following season.
